

This document contains key information you should know about Exemplar Growth and Income Fund, Series AN units. You can find more detailed information in the fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

Notice: Effective on or about October 1, 2018, the fixed-rate management expense for this series is reduced by 0.20% to 0.80%. If this reduction was reflected in the MER, the MER would have been lower.

What does the fund invest in?

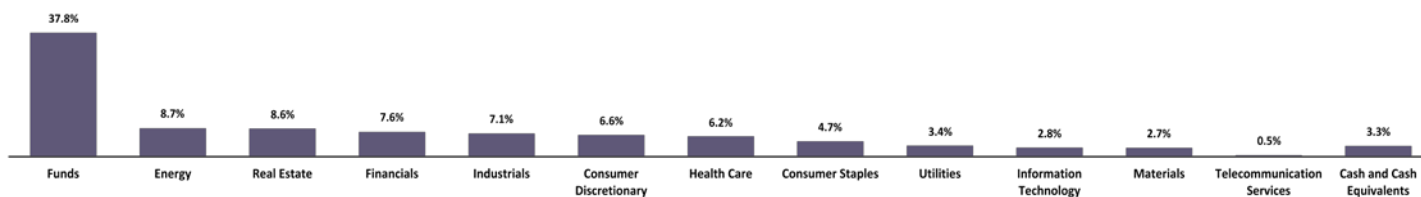
The fund will invest up to all of its assets in a diversified mix of other mutual funds (in order to gain indirect exposure to securities that the fund would otherwise directly invest in), and may also invest in common shares, preferred shares, treasury bills, short-term notes, debentures, and bonds. The fund will invest primarily in Canadian securities but may invest up to 49% of its assets in foreign securities.

The charts below give a snapshot of the fund's investments on August 31, 2018. The fund's investments will change.

How risky is it?

The value of your investment can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

Arrow has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

No guarantees

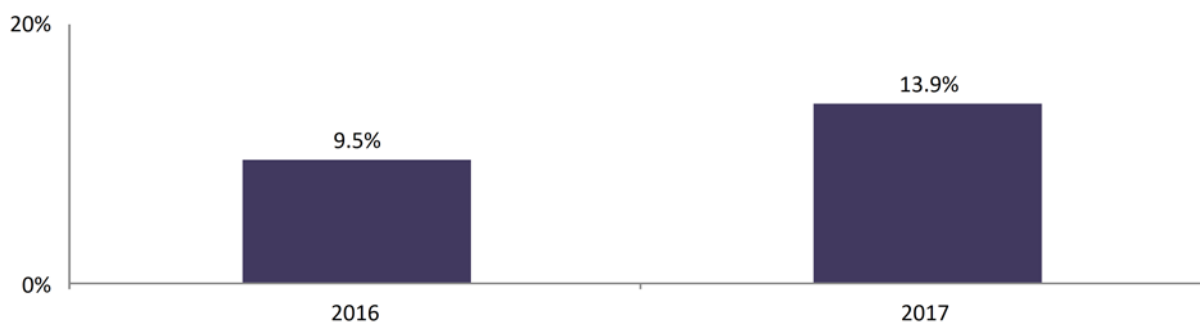
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the money you invest.

How has the fund performed?

This section tells you how Series AN units of the fund have performed over the past 2 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how the fund has performed in each of the past 2 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series AN units of the fund in a 3-month period over the past 2 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in the fund on March 16, 2015 would have \$1,285 on August 31, 2018. This works out to an annual compound return of 7.6%.

Who is this fund for?

Investors who:

- Are looking for regular quarterly income,
- Are prepared to invest for medium to long periods of time, and
- Are comfortable with a low to medium risk level.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund outside a registered plan, fund distributions are included in your income for tax purposes, whether you get them in cash or have them reinvested. If you hold your fund inside a registered plan, you will include fund distributions and other amounts you withdraw from your registered plan in your income for tax purposes. Different rules apply for Tax-Free Savings Accounts.

How much does this cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series AN units of the fund.

The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option.

| Sales charge option | in percent (%) | What you pay in dollars (\$) | How it works |

| Initial sales charge | 0% to 5% of the amount you buy | \$0 to \$50 on every \$1,000 you buy | You and your representative decide on the rate. The initial sales charge is deducted from the amount you buy. It goes to your representative's firm as a commission. |

Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of June 30, 2018, the fund's expenses were 3.45% of its value. This equals \$34.50 for every \$1,000 invested.

| Management expense ratio (MER) This is the total of the fund's management fee (which includes the trailing commission) and operating expenses. Arrow waived some of the fund's expenses. If it had not done so, the MER would have been higher. | 2.49% |

Performance fee

The fund will not pay a performance fee directly, although funds it invests in may be charged a performance fee.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

Arrow pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

| Sales Charge | Amount of trailing commission in percent (%) | in dollars (\$) |

| Initial Sales Charge | 1.0% of the value of your investment each year | \$10 each year on every \$1,000 invested |

Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

| Fee | What you pay |
|------------------------|---|
| Short-term trading fee | Up to 2% of the value of units you sell or switch within 90 days of buying them. This fee goes to the fund. |

| Fee | What you pay |
|------------|---|
| Switch fee | Your representative's firm may charge you up to 5% of the value of the units you switch to another fund managed by Arrow. |

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase order within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
